Adult Education - Definition



Adult education is defined as any form of non-vocational learning for adults after initial education, whether formal, non-formal, or informal.

Key Actions in Adult Education

Key action 1



Learning Mobility of individuals (staff and learners)

- Short-term projects 6-18 months, 30 mobilities, Erasmus accreditation,
- longer term orientated, Organisational Development,
- no limits for mobilities

Key action 2



Cooperation among organisations and institutions

- Small-scale Partnerships- Exchange of good practice
- Cooperation Partnerships – Result-oriented

Activities in Key action 1

Erasmus+ mobility - formats



Mobility of Learners



- Group mobility of adult learners (2 - 30 days, (2 learners minimum per group)
- Individual learning mobility of adult learners: (2 - 30 days).

New: Longterm mobility up to 365 days



Staff mobility



- Job Shadowing (2 - 60 days)
- Teaching assignments: (2 - 365 days)
- Courses and training (2 – 30 days)
(2 different nationalities minimum)
- No purely passive participation
(Conferences)



Special guests and another format



- Invited experts (**2** - 60 Tage)
- Teachers in training who are enrolled or have recently graduated (**10** - 365 days)
- Preparatory visits

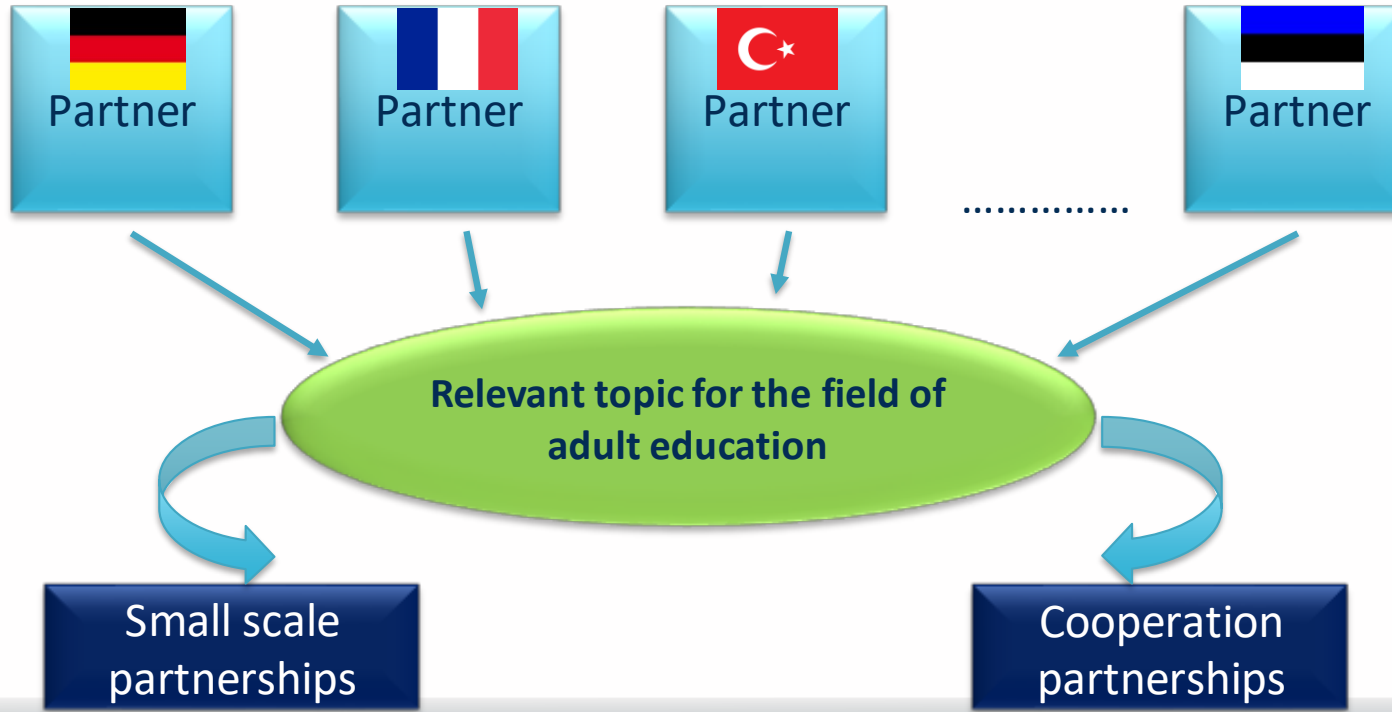

KEY ACTION 2: COOPERATION AMONG ORGANISATIONS AND INSTITUTIONS



Formalities

- Partnerships are open to **any type of organisation** active in any field of education, training, youth, sport or other socio-economic sectors
- Project must address a **relevant topic for adult education**
- Project must address **at least one thematic priority** (Programme Guide, Version 3, pp. 217)
- activities must take place in the **countries of the organisations participating** in the project (exceptions: seat of an Institution of the European Union + dissemination activities at relevant thematic transnational events/conferences in any other country (the latter only applies to Cooperation Partnerships))
- Submit your application **to the National Agency of the country in which the consortium leader is based**

Lump sums in Key Action 2

Cooperation Partnerships

- Result-oriented
- At least 3 organisations from at least 3 countries
- Duration of 1 to 3 years

Small-scale partnerships

- Exchange-oriented
- Ideal for newcomers to Erasmus+
- At least 2 organisations from at least 2 countries
- Duration between 6 months and 2 years
